This document compiles the **Disciplinary Tribunal (HTD) rulings issued in Lugano, Switzerland, during the 2025 FIMBA World Championship**, between **June 28 and July 4, 2025**. Each case (HTD-1 to HTD-17) records disciplinary actions or decisions regarding players, coaches, or teams.

HTD-17 - July 4, 2025

Complaint: TEAM ITALIA and ITALY MB WOMAN MILANO claimed player Svetlana Shomodi (FIMBA ITALIA F55) was not Italian and lacked one year's residence in Italy. **Decision:** The complaint was **rejected** — her residence was certified by FIMBA ITALIA's representative, complying with Article 19 of the Championship Rules.

HTD-16 - July 3, 2025

Incident: Dario Plozzer (Italy NPGR Milano, M60) **pushed a bench player** from the opposing team.

Decision: Two-game suspension (Art. 52 and following of the Penal Code).

HTD-15 – July 3, 2025

Incident: Italy (FIMBA Italia) vs. Canada (M60). Player No. 14 said "VA fanculo" ("Go f*** yourself") to a referee.

Decision: Coach suspended for one match, redeemable by fine (for three technical fouls B).

HTD-14 - July 3, 2025

Incident: Czech Republic player No. 14, Jan Klems, ejected for two technical fouls.

Decision: One-game suspension, redeemable by fine.

HTD-13 - July 2, 2025

Incident: Switzerland C vs. Colombia (M55). Swiss player No. 10 ejected for **technical + unsportsmanlike foul**.

Decision: One-game suspension, redeemable by fine.

HTD-12 - July 2, 2025

Incident: Serbia vs. Italy (M65). Serbian player No. 4 (B. Stojanovic) received technical

+ personal foul, sent to locker room.

Decision: One-game suspension, redeemable by fine.

HTD-11 - July 2, 2025

Incident: Italy vs. Greece (M45). Greek player No. 17 verbally and physically attacked

the referee; coach also threatened her.

Decision: Two-game suspension for both player and coach.

HTD-10 – July 2, 2025

Incident: Switzerland vs. Great Britain (F45). GB coach Ricardo Raggi disqualified for

two technical fouls.

Decision: One-game suspension, redeemable by fine.

HTD-9 - June 30, 2025

Incident: Brazil A vs. Canada (M60). Player No. 33 (Brazil) disqualified after two

technical fouls for repeated protests.

Decision: One-game suspension, redeemable by fine.

HTD-8 – June 30, 2025

Incident: Italy vs. Colombia (M50). Italy player No. 11 (two T's), Colombia player No. 10

(T + U2).

Decision: Both suspended one game, redeemable by fine.

HTD-7 - June 30, 2025

Incident: Colombia vs. Greece (M40). Colombia's No. 41 continued threatening

remarks toward referee, disqualified.

Decision: One-game suspension, redeemable by fine.

HTD-6 - June 30, 2025

Incident: Estonia vs. Spain (M60+). Estonian player No. 10 disqualified for technical +

unsportsmanlike foul.

Decision: One-game suspension, redeemable by fine.

HTD-5 - June 29, 2025

Incident: Switzerland vs. Brazil A (M40). Swiss player No. 44 hip-checked the referee

after a technical foul.

Decision: One-game suspension, redeemable by fine.

HTD-4 – June 29, 2025

Incident: Italy vs. Slovenia (M60). Italian player No. 89 ejected after two technical

fouls.

Decision: One-game suspension, redeemable by fine.

HTD-3 - June 29, 2025

Incident: United Kingdom vs. Estonia (M60). UK player No. 10 technical +

unsportsmanlike foul, expelled.

Decision: One-game suspension, redeemable by fine.

HTD-2 - June 28, 2025

Incident: Switzerland vs. Brazil (M45). Swiss player No. 35 technical +

unsportsmanlike foul, expelled.

Decision: One-game suspension, redeemable by fine.

HTD-1 - June 28-29, 2025

Incident: Australia vs. Ireland (M50). Andrew Parkinson (Australia) **headbutted** Irish player Walsh.

Initial Decision: Two-game suspension for physical aggression (Articles 51–78). **Appeal (June 29): Appeal rejected** — the court upheld the two-match ban after reviewing referee testimony.
